

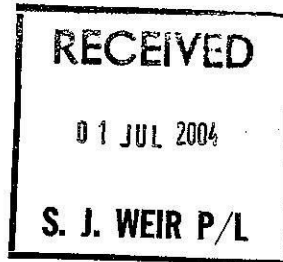

CONSTRUCTION SUPPLIER REGISTER REVIEW OF COMPLIANCE WITH FINANCIAL AND OCCUPATIONAL HEALTH & SAFETY CRITERIA

INTERIM PRE-QUALIFICATION ARRANGEMENTS TO SEPTEMBER 2004

This is to advise that S J Weir Pty Ltd will retain interim pre-qualification with the Construction Supplier Register (the CSR) until September 2004. This decision follows the review of its compliance with the CSR financial and Occupational Health and Safety (OH&S) pre-qualification criteria.

Interim pre-qualification details for S J Weir Pty Ltd are:

Pre-qualification category(ies):

**Commercial Refurbishment
New Commercial Construction
Office Fitout**

Financial pre-qualification level: **\$100,000 to \$25,000,000**

Interim pre-qualification has been granted because you met the following requirements of the review:

- You submitted OH&S documents that have been assessed as complying with the minimum mandatory OH&S criteria; and
- You submitted adequate financial data for the CSR assessment purposes (for most contractors this was 2002-2003 financial statements).

The interim arrangement will allow time for the CSR to further analyse the financial data of all pre-qualified contractors to establish financial pre-qualification criteria into the future and to verify whether contractors are in the correct pre-qualification category. For your information approximately 210 pre-qualified contractors have been granted interim pre-qualification.

FINANCIAL ASSESSMENT IN SEPTEMBER 2004 AND BEYOND:

Unless the CSR notifies otherwise interim pre-qualification will remain in place until September 2004 when I will write to you to obtain 2003-2004 financial statements. These will be assessed against the CSR pre-qualification criteria to verify whether the interim level of financial pre-qualification outlined above is justified.

Even though you met the requirements of the review you will still need to provide the CSR with your 2003-2004 financial statements when requested to do so. As you know the CSR reviews pre-qualification on a regular basis and in future you will need to provide annual financial statements to continue to be eligible for pre-qualification.

To help you prepare for the September financial assessment the CSR will send you a package of information before the end of July 2004. The Package will contain more details of the CSR financial pre-qualification criteria and a summary of the financial data held by the CSR for S J Weir Pty Ltd. You should take note of the information in the package and use it to ensure that your 2003-2004 financial statements meet the CSR financial pre-qualification criteria.

For some contractors an increase or a decrease in financial pre-qualification level may be justified after the September assessment. In a small number of cases I expect further discussions to be necessary to ensure compliance with all of the pre-qualification criteria
